## GLOBAL CITIZENSHIP BURSARY - 20 Bursaries at \$1,000

Centennial College is pleased to advise our College community that we have allocated funding to provide 20 Global Citizenship Bursaries for Ontario students enrolled in fulltime Ministry approved programs of study. This bursary recognizes student involvement and commitment to global citizenship and equity outside the classroom.

### Eligibility Criteria:

- you must be a Canadian, Permanent Resident or Protected Person
- you must have been a resident of Ontario for 12 months prior to the start date of your fulltime program
- you must be enrolled fulltime at Centennial in a Ministry approved program of study
- you must fully complete this application prior to submission – failure to complete the application in full will result in denial of consideration
- you must have a minimum financial need that exceeds the value of the bursary (\$1,000)
- you must have completed GNED-500 with a minimum grade of 'B'
- you must have been engaged with global citizenship and equity as well as social justice activities outside of the classroom within the last 12 months
- you must demonstrate your global citizenship and equity engagement by providing a one page essay (300 word max) description of your leadership involvement, initiative and innovation in promoting global citizenship, social justice and equity at Centennial, across Canada or internationally. (Do NOT submit more than one page as any additional pages will be removed from your submission and not considered.)

If you believe you meet the above criteria, please submit as requested below (1) your personal information, (2) complete your student declaration below, (3) on the reverse, complete the financial needs eligibility assessment, (4) complete your Student Declaration on reverse and (5) attach your one page essay as identified above. **IMPORTANT NOTE: Applications submitted to individuals, departments or locations other than noted below and not subsequently forwarded within the deadline to S. George will not be considered for this opportunity.**

*Second Career, International, Apprentice and Part time Day and Continuing Education students are ineligible for this bursary.*
